



Off-Licence

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Licence Number: 47/OFF/46/2020

Pursuant to the Sale and Supply of Alcohol Act 2012, NZ VENUE CO LIMITED is authorised to sell alcohol on the premises situated at 74 Ararino Street, Upper Hutt and known as Tote & Furnace (Super Liquor), to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- No alcohol is to be sold or delivered on Good Friday, Easter Sunday or Christmas Day, or before 1pm on ANZAC Day.
- The whole of premises is designated as a supervised area.
- Drinking water must be freely available at all times samples are being provided.
- Alcohol may be sold or delivered only on the following days and during the following hours:

Monday to Saturday
Sunday

7.00am to 10.00pm.
9:00am to 10:00pm

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE:

A copy of this licence must be displayed in the interior of the premises so as to be easily read by persons using the premises. The entrance from 74 Ararino Street, Upper Hutt is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- Either-
 - Until the close of the period for which it was last renewed; or
 - If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- If an application for the renewal of the licence is duly made before the licence would otherwise expire, either-
 - Until the close of the period of 3 years after the period for which it was last renewed; or
 - If it has never been renewed, until the close of the period of 4 years after the day it was issued
