# OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

**033/OFF/160/2015**

**Pursuant** to the Sale and Supply of Alcohol Act 2012 (the **Act**), Yong ZHOU (the licensee) is authorised to sell alcohol on the premises situated at 3 McLean Street WAITARA 4320 and known WAITARA SUPER LIQUOR, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

This licence is subject to the following conditions:

Conditions
The <b>OFF LICENCE</b> be renewed for three (3) years from the date of expiry <b>1 September 2021</b>
Alcohol may be sold only on the following days and during the following hours: <b>Monday to Saturday</b> <b>8:00am to 9:30pm</b> <b>Sunday</b> <b>9:00am to 9:30pm</b>
No alcohol is to be sold or delivered on the premises on <b>Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day</b>
<b>The whole of the premises is designated as a SUPERVISED area.</b>
<b>A certified manager must be on duty at all times during the sale and supply of alcohol.</b>
Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample on the premises
The licensee must ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence expires on:
